  - "that the current Green Flag sites (2 no.) are entered for Green Flag accreditation 2019/20 at a cost of £350 per site, total £700, to be financed from budget no. 7.01 GTC Management Plan Work".
  - "that POS Shires Gate and POS Shreen Meadow are jointly entered for Green Flag accreditation in 2019/20 (first time) at a cost of £350 to be financed from budget no. 7.01 GTC Management Plan Work".
  - "that those sites entered for Green Flag 2019/20 are also entered for South West in Bloom Pride in Parks Award 2019 at a cost of £20 each, total £60, financed from budget no. 7.01 GTC Management Plan Work".
  - "that staff/councillors (approximately 10 no. persons) attend the South West in Bloom Spring Seminar on Thursday, 28<sup>th</sup> February2019, at a cost of £18 per delegate, total £180, to be financed from budget no. 8.21 staff training".
  - "that battery powered hand tools are purchased from Supplier no. 1 at a cost of £2,603.66 plus VAT and financed from budget no. 502 Replacement Small Plant Tools".
- 8. To consider and agree additional signage to promote more Green Flag sites and inform people about the criteria for Green Flag sites.
- 9. To consider and agree refurbishment costs for the Workshop deferred from the General Purposes Committee meeting held on 14<sup>th</sup> January 2019.
