(a)	Regulation no. 3 & 6: Following the current guidance from NALC and the Government, the council is asked to consider the suspension of the Annual Town Assembly until April 2021.			
	It was agreed and RESOLVED that the Annual Town Assembly is suspended until April 2021 as permitted under the Coronavirus Act 2020, s.78, Regulations 3 and 6.			
(b)	Regulations no. 3 & 6: Following the current guidance from NALC and the Government, the council is asked to consider the suspension of the Annual Council Meeting until May 2021.			
	It was agreed and RESOLVED that the Annual Town Meeting is suspended until May 2021 as permitted under the Coronavirus Act 2020, s.78, Regulations 3 and 6.			
(c)	Regulation no. 4: Following the current guidance from NALC and the Government, the council is asked to consider that the election of Mayor and Deputy Mayor is postponed until May 2021.			
	No vote was taken on this item for the reasons as follows: • Minute no. 222(b) above, resolved that the Annual Council Meeting is suspended until May 2021.			
	• The Local Government Act 1972, s.15(2), requires the first business of the Annual Town Meeting to elect a Chairman (in the case of Gillingham, a Mayor). As there will be no Annual Town Meeting in 2020, the election of The Mayor and Deputy Mayor will not take place until May 2021.			
(d)	Regulation no. 5: Following the current guidance from NALC and the Government, the council is asked to consider that all Town Council meetings are held remotely until Government rules on social-distancing have been relaxed, and that the council's Standing Orders are amended accordingly to include procedures for holding remote meetings (see attached, Standing Order no. 27).			
	A copy of the proposed Standing Order no. 27 and Addendum no. 1 was circulated prior to the meeting. Please refer to Appendix A.			
	It was agreed and RESOLVED that as long as The Local Authorities and Police and Crime Panels (Coronavirus) (Flexibility of Local Authority and Police and Crime Panel Meetings) (England and Wales) Regulations 2020 (Regulations) remain in force, the Town Council will conduct remote meetings using appropriate technology as per the Coronavirus Act 2020, s.78, Regulation no. 5.			
	It was agreed and RESOLVED that Addendum no. 1, as presented, is added to the Council's Standing Orders.			
(e)	Regulation no. 13: To receive confirmation that the Town Council continues to post copies of the agenda on the notice board at the Town Hall and other locations (if possible) and on the Town Council's web site.			
	It was noted that Gillingham Town Council will continue (providing it is safe and possible to do so), to post copies of the agenda on the Council's notice boards and on the Council's web site as per the Local Government Act 1972, s.232, Public Bodies (Admissions to Meetings) Act 1960, s.1(4) and the Coronavirus Act 2020, s.78, Regulation no. 13.			

(f)	Regulation no. 17: To receive confirmation that the Town Council continues to make available copies of the agendas, minutes and background papers available to members of the public via the Town Council's web site or on request.
