a. Application No.: 2/2018/1724/FUL

Proposal: Change of use from detached garage (part section only) to hairdressing salon

and associated external alterations (retrospective).

Location: 24 Wren Place Gillingham SP8 4WE

Following a discussion, Cllr Mrs Pothecary proposed that "Gillingham Town Council has no objection to the application". Cllr Gould seconded, the majority voted in favour of the proposal. Cllr Von Clemens abstained from voting as he had concerns over parking.

**Proposal:** Erect chimney to north west elevation.

Location: Squirrels Dray, Bowridge Hill, Gillingham, Dorset, SP8 5QS

Following a discussion, Cllr Von Clemens proposed that "Gillingham Town Council has no objections to the application as the proposed chimney will not protrude above the ridge height and is not over-dominant." Cllr Mrs Hunt seconded, the vote was unanimous. RESOLVED

## 690. Planning Applications continued:

c. Application No: 2/2019/0242/HOUSE

Proposal: Erect a single storey front extension and erect single storey extension to

garage.

Location: 12 Highgrove, Gillingham, Dorset, SP8 4SA

Following a discussion, Cllr Mrs Pothecary proposed that "Gillingham Town Council has no objections to the application as the proposal with not result in any unneighbourly issues or highway issues and the proposed materials will match." Cllr Von Clemens seconded, the majority of members voted in favour of the proposal. Cllr Miss Purkis objected to the application over concerns that the proposal will not be in keeping with the street scene. **RESOLVED** 

**d. Application** No: 2/2019/0227/FUL

**Proposal**: Install Biomass heating system flue on existing unit, erect shed (retrospective).

Location: Unit 27, Brickfields Industrial Estate, Gillingham, Dorset, SP8 4LT

The Chairman informed the meeting that the description of the application has changed to include the erection of the shed on the site and now reads: *Install Biomass heating system flue on existing unit, erect shed (retrospective).* 

Following a discussion, Cllr Mrs Pothecary proposed that "Gillingham Town Council has no objections to the application as the proposal supports environmental and economic policies and is not detrimental to neighbouring properties or to the street scene." Cllr Gould seconded, the vote was unanimous. RESOLVED

691. To consider an application by Countryside Access Management Ltd to North Dorset District Council (now Dorset Council) for an order to divert Footpath 34, Gillingham, under section 257 of the Town and Country Planning Act 1990.

The Chairman outlined the proposal to divert Footpath No. 34 and invited the Rights of Way Liaison Officer to speak.

Mrs Messer, Rights of Way Liaison Officer commented on the proposal.

Following a discussion, Cllr Von Clemens proposed that "Gillingham Town Council has no objections in principal to the proposed diversion but wish the following comments to be taken into consideration:

- The proposed diversion X Z Y follows the proposed highway, however, in practice, pedestrians will follow a desire-line and it is anticipated that despite the diversion, pedestrians will continue to use the existing route between X and Y.
- The proposed diversion C F passes between two proposed dwellings. Although this is a fairly short and straight section, high fences on either side of the footpath must not physically dwarf users of the footpath or be oppressively high. High fences/walls along this section of the footpath could result in this section becoming a stark and intimidating footpath, overwhelmed by the height of the fence/wall, which in turn could lead to users becoming vulnerable to crime. Therefore, the width of this section C F should be as wide as possible and any fencing/walls on either side of the path should be kept low".

Seconded by Cllr Gould the majority voted in favour of the proposal. Cllr Mrs Beckley abstained from voting.
