a) Application No: <u>P/HOU/2025/06005</u>

Proposal: Erect single storey rear extension with roof lantern and erect front porch.

Form raised rear patio/ terrace area.

Location: 12 Stour Meadows, Gillingham, SP8 4SG

Ward: Wyke

It was agreed and **RESOLVED** that the town council supports application no. P/HOU/2025/06005 as the single storey extension will not impact neighbours' amenity or privacy. The design is in keeping with the existing property and will not harm the street scene and the proposal represents good design and appropriate use of materials.

b) Application No: P/PAAC/2025/06038

Proposal: Change of use and conversion of agricultural building to dwellinghouse (use class C3).

Location: Viaduct Farm, Nations Road, Bugley, Gillingham, SP8 5RA

Ward: Rural

It was agreed and **RESOLVED** that the town council supports application no. P/PAAC/2025/06038 subject to a satisfactory ecology survey being provided, demonstrating that there will be no adverse impact on protected species or habitats.

Cllr Snook abstained from voting. Cllr Hurst voted against the application.
