# Memorandum received from Dorset Council Tree and Landscape Officer Re. New Tree Preservation Order TPO/2021/0004

The following is a memorandum received from Dorset Council Tree Officer.

This is to inform you that the provisional Tree Preservation Order (TPO) has been made at Land North East of The Mellowes Nursing Home Common Mead Lane Gillingham, Dorset on for the following reason(s):

The following is the statement of the Council's reasons for making the Order (as required by **REGULATION 5** of The Town and Country Planning (TREES) Regulations 2012):

"In view of the outline development submitted for consideration under P/OUT/2020/00472; an assessment has been undertaken and it is the Councils view that the trees detailed within the survey of the site contribute positively to the amenity of the locality. A number of veteran trees have also been identified and their long-term protection and retention is sought.

The Order has been made an Area at this stage, until such a time a site visit can be undertaken and a full assessment can be made."

As mentioned the order is currently provisional and the Council will have six months, from the date on the order, in which to decide whether the order is to be confirmed or not.

All representations or valid objections regarding the order received within the 28 day notice period will be considered prior to any decision being made.

In the absence of any objections the order will be confirmed, with or without modification, under powers delegated to the Service Manager for Conservation.
