296. To receive and consider planning applications, as follows:

a) Application No: P/RES/2020/00218

Proposal: Erect 2 No. dwellings. (Reserved matters application to determine appearance and landscaping; following grant of Outline Planning Permission 2/2020/0199/OUT).

Location: Ham Cottage, Cole Street Lane, East Stour, SP8 5JG

It was agreed and **RESOLVED** to recommend approval of Planning Application P/RES/2020/00218 subject to approval by the Dorset Council Tree and Landscaping Officer and subject to the provision of adequate cycle storage.

b) Application No: P/LBC/2021/00039

Proposal: Addition of decorative plasterwork to existing Hall ceiling **Location**: The Old House, Milton-on-Stour to Wavering Lane – Road, Milton-on-Stour, SP8 5PX

It was agreed and **RESOLVED** to recommend approval of Application P/LBC/2021/00039 for the following reasons:

- the proposal will improve and enhance the ceiling;
- the work is reversible, and
- damage to the existing, relatively modern ceiling, will be minimal.

c) Application No: <u>P/HOU/2021/00066</u>

Proposal: Erect single storey rear extension and convert loft into additional accommodation

Location: Nursery End Cottage, Bay Lane, Gillingham, SP8 4ER

It was agreed and **RESOLVED** to recommend approval of Application P/HOU/2021/00066 for the following reasons:

- The design of the proposed extension is sympathetic to the existing dwelling;
- The rooflights will be situated at the rear of the property, and
- The proposals will not be overbearing or detrimental to neighbouring properties.
